1.In exercise of the powers conferred in the Government Order 1st read above, an Administrative Sanction is accorded to the 2 Municipal Corporations and 4 Municipalities as in the Annexure for the construction of 9 nos. of modern Slaughter house for the amount noted against each with a total estimated cost of Rs.290.00 lakh (Rupees Two crore and ninety lakh) as communicated to the concerned Corporation & Municipal Commissioners and Executive Officers in this office letter 2nd read above, with a grant of Rs.156.15 lakh (Rupees One crore fifty six lakh and fifteen thousand) shown against each ULB under the Infrastructure Gap filling fund of Third State Finance Commission recommendation grant, for the year 2011-12.

2. No additional grant for the works over and above the allocation indicated in the Annexure against each ULB will be permitted and any excess over the grant amount allotted shall be met from the ULB funds taking appropriate ^{approvals} ~~efforts~~ from ULBs.

3. The works have been approved based on the proposal received from Commissioners of ULBs and if any dispute is reported later, severe action will be taken against the officers concerned.

4. The necessary further steps for obtaining the Technical Sanction from competent authorities for the estimate should be taken immediately and tender to be floated following the prevailing relevant Act and Rule provisions without fail. The works should be completed by March 31st 2012.

5. The Tamil Nadu Pollution Control Board approval shall be obtained in all cases without fail.
