In this office memorandum the provisional seniority list of Assistant Engineers / Junior Engineers was communicated to all concerned. Certain Assistant Engineers/ Junior Engineers had represented to re-fix their seniority with reference to the actual date of entry into service , change of place and to includes their names. After verification of their claims the final seniority list has been prepared and the same is communicated to all concerned herewith. Engineers have raised certain objections/ suggestions and have been appropriately incorporated as follows:

1) Thiru M.Gobinath, Sathyamangalam has requested to place his name in JE seniority list as he has completed BE during May 2008 and his date of appointment of JE is 1.10.1995. His request is accepted.

2) Thiru.A.Shanmugam, Nallur has requested to place his name as per the final seniority list communicated on 19.12.2006. His request cannot be considered as such. However as he was appointed as JE on 30.6.1995 if his name is included in the JE seniority list the individual will get benefit as his name will be placed after the name of Thiru S.Backiasamy.

3) Thiru N.Saravanakumar, Usilampatti Municipality has requested to include his name in the provisional seniority list of AE. His request cannot be considered. However if his name is included in the JE seniority list the individual will get benefit as his name will be placed in between Thiru K.Manivannan (Sl.No.49) and G.Thangapandian.(Sl.No.51)

4) Thiru.V.Nataraj, Attur Municipality, has requested to include his name in the provisional seniority list at appropriate place as his name is left out. Though the applicant is working as AE he does not belong to Municipal Service. He is an employee of Salem Corporation and was transferred. His request may not be considered favourably.

5) Tvl.P.Sekaran, Kuniyamuthur III Grade Municipality, M.Ganesan, Mettupalayam, B.K.Ramesh, Kuzhithurai Municipality A.Ravi, Thiruverkadu III Grade Municipality G.Anandajothi, Walajapet and has requested to include their name in the list AE since he has been redesignated as AE on 31.10.1997 20.11.2002,

6.1.2003 17.9.2005 and 15.12.2006 respectively. Their request are accepted. and included in the AE seniority list at the appropriate place.

6) Tvl. R.Radha, Sivakasi, R.Murugan, Hosur, S.Suresh, Nagercoil, Tmt. V.Chitra, Pudukottai has requested to include their name in the provisional seniority list of AE. The provisional seniority list is prepared based on the final seniority list communicated on 19.12.2006. They were appointed only after 31.12.2006. Hence their name may be included in the subsequent seniority list by calling for particulars from the remaining AE/JEs.

7) Thiru P.Khader Mohideen, AEE, working in DTP on deputation basis has requested to refix his seniority as per the present G.O. i.e. he has requested to implement the G.O. with retrospective effect and requested to give priority in the seniority list of EE. Regarding request No.1, since no retrospective effect is given in the G.O. only prospective effect can be given. The second request is irrelevant to the issue now dealt with. His request may not be considered.

8) Tvl.M.Karthikeyan, Melur, G.Elangovan, Rasipuram, Tmt. K.Karupathal, Dharapuram, A.Alavudeen, Kasipalayam, P.Manoharan, Vellore Corpn. (on deputation) K.Vaithialingam, Alandur, and R.Purushothaman has requested to fix their seniority based on the final seniority communicated in Memo. dated 19.12.2006. As the rule has been amended fixing the ratio between AEs and JEs their request cannot be complied with as it is against the rules as amended now.

9) Thiru S.Sekar, DTP (on deputation) has requested to place his name before Sl.No.14 instead of 16 as he was appointed as JE before those persons. The seniority of JEs were already confirmed and communicated in this office Memo. dated 19.12.2006. Hence that seniority cannot be altered now. His request is not accepted.

10) Thiru K.Rengarasu, Aranthangi has requested to fix his seniority in the AE list according to his date of promotion as AE. His request is accepted.

11) Tvl. S.Ramasamy, DTP., N.S.Kannan, Kovilpatti P.Radhakrishnan, DTP., has requested to include their name in the provisional seniority list of AE since they are working as AE from 26.2.2004, 28.12.2005 and 15.12.2006. Their names are omitted in list. Hence their requests are accepted. and their names are included in the appropriate place.

12) Tmt. S.K.Suganthy, DTP has requested to revise her qualification and present station as ME and DTP respectively and requested to fix her seniority according to roaster and date of appointment and place her above Sl.No.56. Her qualification and present station is corrected. Regarding her request of revising her own seniority the issue was already settled vide seniority communicated in this office Memo. dated 19.12.2006.

13) Thiru N.Raja, Mayiladuthurai has requested to place his name after Sl.No.6 and before Sl.No.7 as he was completed his BE in November 1997. In this office Lr.No.41092/2005/F2, dated 9.9.2005 his appointment has as JE has been regularised from 14.10.1997 notionally. Since he has completed his B.E. in November 1997 his request is accepted and his name is included in the appropriate place.

14) Tvl. / Tmt. M.Lalithamani, Coimbatore Corporation, T.M.Menaka Dhinakar, DTP, V.Balamurugan, Tmt. R.Manonmani, DTP. S.Palanisamy, Tmt. V.R.Mallikai, has requested some of the AEs who were appointed after their appointment are placed above them and hence requested to rectify the anomaly. The applicants are direct recruits and their contention that the juniors are placed above them are not true as the seniority is fixed at the time of selection based on rank, roaster and communal rotation. As their seniority are based on approved selection list of AEs their request are not accepted.

15) Thiru G.Thangapandi, DTP (on deputation) has requested to include his name in the seniority list of JE as his name was left out. His name was omitted in the list. Hence his request is accepted, and his name is included in the appropriate place.

16) Thiru P.Natesan, Salem Corporation (on deputation) has requested to add his additional qualification such as ME.,(Structural Engg) and MBE., and requested to revise the seniority list retrospectively. His qualification is added and revising of seniority already published can not be considered retrospectively.

A final seniority list of Assistant Engineer/Junior Engineer working in various Municipalities / Municipal Corporations and Directorate of Town Panchayats are communicated in the Annexure enclosed.

The Commissioners of Municipalities, Corporations and Director of Town Panchayats shall ensure that the final seniority list is communicated to the concerned Assistant Engineers/Junior Engineers.
