ORDER:

In the letter read above, the Commissioner of Municipal Administration has stated that, the Commissionerate of Municipal Administration has been appointed as the State level nodal agency for IHSDP schemes implemented in the state of TamilNadu. The Ministry of Housing and Urban Poverty Alleviation (HUPA), Government of India has approved the IHSDP project for the construction of Houses and infrastructure facilities to the slum dwellers (Urban poor) of Aruppukottai Municipality at a project cost of Rs.2088.60 lakh under IHSDP as detailed below:

2. The Commissioner of Municipal Administration has also stated that, in the G.O. (Ms) No. 85, Municipal Administration and Water Supply Department, dated 15.6.2007, the Government have delegated the administrative powers of sanctioning upto Rs. 25.00 crore to the SLSCMC committee and also the administrative sanction for the individual infrastructure projects i.e. Roads and others are vested within the powers of Municipal Council/Regional Director of Municipal Administration/ Commissioner of Municipal Administration. The Ministry of Finance Department of the expenditure has now released the total amount to Rs. 765.13 lakh as the 1st installment share of Government of India to Arupukottai Municipality for the year 2010 – 2011.

3. The Commissioner of Municipal Administration has therefore requested the Government to sanction and release a sum of Rs. 765.13 lakh towards the GOI Share of 1st Installment for the year 2010 – 2011.

4. The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 3 above, accord sanction and release a sum of Rs.765.13lakh towards the GOI Share of 1st installment for the year 2010-2011 under the Integrated Housing and Slum Development programme (IHSDP) scheme.
