#### **ORDER:**

The Commissioner of Municipal Administration has requested the Government to sanction the above posts, from the date of filling up of the posts to 31.10.2011 (or) till the need therefor ceases, whichever is earlier.

2. The Government after careful examination of the above proposal of the Commissioner of Municipal Administration, accept the same and accord sanction for the creation of following posts, purely on temporary basis, to attend to the works relating to the Ordinary Urban Local Bodies' Election, 2011:

The sanction of the above posts is subject to the following conditions:

- (i) The posts shall be in existence from the date of their filling up to 31.10.2011 or till the need therefor ceases, whichever is earlier. The said posts are sanctioned purely on temporary basis and they shall cease to exist after 31.10.2011
- (ii) The additional posts sanctioned above should be filled only through redeployment and not by fresh recruitment.
- (iii) The expenditure on account of the employment of the said temporary posts in respect of Municipalities shall be met from the funds of the respective Municipalities.
- (iv) In respect of posts in the office of the Commissioner of Municipal Administration, the expenditure shall be met from the existing salary head of account.


