ORDER:

In the letter second read above, the Commissioner of Municipal Administration has stated that the Government of Tamil Nadu have sanctioned and released 1st instalment of State and Central share to the ULBs as detailed in Annexure to this order.

2. In the G.O. third read above, the Government have released 100% GOTN share of 2nd instalment to the ULBs of Salem Corporation, Villupuram, Ariyalur and Kancheepuram Municipalities in anticipation of release of GOI share of 2nd instalment (100%) to ULBs.

3. The Utilization certificates for the 2nd instalment claims of the ULBs have already been forwarded to the Ministry through a special messenger on 7.12.2010 and 6.1.2011 along with third party inspection monitoring agency (TPIMA) report/Quality Assurance report. The subject on the above proposal for release for 2nd instalment of GOI share was placed in the 04th CSC on 17.1.2011 and was approved by Central Sanctioning Committee (CSC).

4. The Commissioner of Municipal Administration has also stated that in the Sanction order No. 59 (6) PF-I, 2010 – 1273, dated 18.2.2011, the Government of India, Finance, in the letter first read above has released a sum of Rs. 585.04 lakh to the 4 ULBs of Salem Corporation, villupuram, Ariyalur and Kancheepuram as detailed in the Annexure to this Government order.

5. The Commissioner of Municipal Administration has therefore, requested the Government to sanction and release 50% of the 2nd instalment the Central Share (considering to 25% of the GOI project cost) of Rs. 585.04 lakh to the four ULBs as mentioned in the Annexure pertaining to the year 2010-2011 under Integrated Housing and Slum Development Programme (IHSDP) Scheme and Government Order for balance GOI 50% share of 2nd instalment to the ULBs will be sought separately on receipt of funds.

6. The Government after careful consideration sanction and release a sum of Rs. 5,85,04,000/- lakh (Rupees Five crore and Eight five lakhs and four thousands only) to the four ULBs as mentioned in the Annexure for the year 2011-2012 as part of the second instalment of 2010 -11 for IHSDP Scheme under JNNURM.

7. The amount sanctioned in para 6 above shall be debited to the following head of account
