#### ORDER:

In the letter read above, Director of Municipal Administration has stated that the Government of India in the 9<sup>th</sup> Central Sanctioning and Monitoring Committee Meeting on 2.2.2007 approved BSUP project at a cost of Rs. 5535.54 lakhs at Ukkadam, Coimbatore. The Government of India through Ministry of Finance vide release letter F.No. 44/PF.1/2006-2007, dated 31.3.2007 has recommended for release of Rs. 303.90 lakh additionally, in addition to Rs. 517.25 lakh to the Tamil Nadu Slum Clearance Board for the construction of houses and infrastructure facilities at Ukkadam – Coimbatore towards the Government of India share (25% of Central share) of 1<sup>st</sup> instalment for the BSUP project.

2. The Director of Municipal Administration also stated that, in the letter dated 14.5.2007, that office has sought for clarification from the Ministry of Finance regarding the excess release of Rs. 303.90 lakh towards Ukkadam project of Slum Clearance Board. In response of the above, the Ministry of Finance has issued release orders for Rs. 692.12 lakh for construction of houses and infrastructure facilities for phase II project for Coimbatore Corporation after adjusting Rs. 303.90 lakh as excess release made towards Ukkadam Project to the Tamil Nadu Slum Clearance Board, Coimbatore.

3. The Director of Municipal Administration has further stated that, the amount of Rs. 303.90 lakh as excess release made to Ukkadam Project of Tamil Nadu Slum Clearance Board has been adjusted by the Government of India towards its release made for construction of houses and infrastructure facilities for Coimbatore Phase II Project.

4. The Director of Municipal Administration has requested the Government to issue orders, for the release of the balance amount of Rs. 692.12 lakh ( Rs.996.02 lakh – Rs. 303.90 lakh = Rs. 692.12 lakh ) to the Director of Municipal Administration (SLNA) for onward transmission towards 1st instalment share to Phase II BSUP Project of the Coimbatore Corporation.

5. The Government after careful consideration, accept the proposal of Director of Municipal Administration, at para 4 above sanction and release an amount of Rs. 692.12 lakh as 1st installment share to Phase II BSUP Project of the Coimbatore Corporation for the scheme of BSUP under JNNURM.

6. The amount sanctioned in para 5 shall be debited to the following head of account

**I - General Component – Rs.512.17 Lakh (74%)**

"2217 Urban Development – 04. Slum Area Improvement – 192 Assistance to Municipalities / Municipal Councils – II. State Plan-JC. Jawaharlal Nehru National Urban Renewal Mission (JnNURM)- Basic Services to Urban Poor – Controlled by Commissioner of Municipal Administration – 09 Grants-in-aid-02. Grants for capital expenditure. (D.P.Code No.2217-04-192-JC-0923)".

**II – Special Component – Rs.179.95 Lakh (26%)**

"2217 Urban Development – 04. Slum Area Improvement – 789. Special Component Plan for Schedule Castes State Plan JH. Jawaharlal Nehru National Urban Renewal Mission (JnNURM) – Basic Services to Urban Poor under Special Component Plan controlled by Commissioner of Municipal Administration – 09 Grants-in-aid-01 Grants for current expenditure. (D.P.Code No.2217-04-789-JH-0919)".

The Director of Municipal Administration is authorized to draw the amount sanctioned in para 5 above by means of cheque in favour of Director of Municipal Administration's BSUP Savings Bank Account No: 30120509278 maintained in State Bank of India, PWD Complex, chepauk, Chennai-5 so as to disburse the same to Coimbatore Corporation.
