The Director of Municipal Administration has also requested the Government to release the amount of Rs. 471.57 lakh sanctioned by Government of India as 3rd Installment for the above 11 ULBs and corresponding State Share of Rs. 396.86 lakh totally Rs. 868.43 lakh (GOI Rs. 471.57 lakh + GOTN Rs. 396.86 Lakh = Rs. 868.43 lakh) for the above 11 Urban Local Bodies to Director of Municipal Administration's BSUP Savings Bank Account No. 30120509278 maintained in the State Bank of India, Chepauk, Chennai – 5.

3. The Government after careful consideration, accept the proposal of Director of Municipal Administration and release an amount of Rs. 868.43 lakh (Eight crore sixty eight lakh and forty three thousand only) (GOI Rs. 471.57 lakh + GOTN Rs. 396.86 Lakh = Rs. 868.43 lakh) towards BSUP scheme as 3rd installment for the year 2010-2011 for the above 11 Urban Local Bodies.
