ORDER:

In the letter read above, the Commissioner of Municipal Administration has stated that, in the G.O. (D) No. 620, Municipal Administration and Water Supply (MA 2) Department, dated 24.12.2010, the Government have sanctioned and released a sum of Rs.10656.17 lakh (Rupees One hundred and six crore fifty six lakh and seventeen thousand only) towards the Central & State Share as 2nd installment towards implementation of Basic Services to the Urban Poor (BSUP) Scheme to the following 5 Implementing Agencies as detailed below:

3. The Commissioner of Municipal Administration has also stated that, as per the above Statement, the first 4 implementing agencies were given the entire funds claimed. For the 5th implementing agency namely Ezhil Nagar, out of Rs.8926.76 lakh due, only Rs.7256.29 lakh has been released due to lack of funds in the Budget Estimate for 2010 - 11. However vide U.O.No: 60433/2010, dated: 14.01.2011, Finance Department has communicated the Revised Estimate for 2010-2011 in which allocation for the BSUP funds have been revised to Rs.372.00 Crore as against Rs.200.00 Crore in the Budget estimate for 2010 - 11. Hence, the Commissioner of Municipal Administration has stated that remaining amount of Rs.1670.47 lakh due to BSUP project of Ezhil Nagar may be released to Ezhil Nagar, Tamil Nadu Slum Clearance Board from the Revised Estimate for 2010 - 11.

4. The Commissioner of Municipal Administration has, therefore, requested the Government to issue orders to release funds to Ezhil Nagar, Tamil Nadu Slum Clearance Board as detailed below.
