State Finance Commission – Recommendations of Third State Finance Commission – Recommendations on the devolution of resources from the State Government to Local bodies – Ratio for sharing State's Own Tax Revenue with local bodies for the year 2011-12 – Orders – Issued.

ORDER:

In the Government Order fourth read above, orders have been issued on the devolution of funds to local bodies at 10% from State's Own Tax Revenue for the year 2010-11 based on the recommendations of Third State Finance Commission and as accepted by the Government. It was also ordered therein that the devolution of funds for the last year of the award period would be issued during the year to follow

2. The Government have earlier decided to devolve funds at 10% from State's Own Tax Revenue, to the local bodies for the year 2011-12 which was communicated in the Explanatory Memorandum on the Action Taken on the recommendations of Third State Finance Commission placed in the Legislative Assembly on 10.05.2007.

3. Accordingly, the Government issue the following orders:

- i. The devolution of funds to the local bodies from State's Own Tax Revenue for the year 2011-12 shall be at 10%.
- ii. This order shall take effect from 01.04.2011.
