In his letter read above, the Director of municipal Administration has stated that, the Ministry of Housing and Urban poverty Alleviation, Government of India in its meeting of the 21th Central Sanctioning and Monitoring Committee (CS&MC) held on 29.10.2007 had approved the project to Madurai Corporation Phase – III for construction of new houses 10688 @ Rs. 110000/- along with provision of infrastructure at a project cost of Rs.17674.86 lakh (Gol – Rs.8712.57 lakh, GOTN – Rs.5506.17 lakh, ULB share – Rs.3206.40 lakh and Beneficiary Contribution – Rs.249.73 lakh)

2. The Government of India released a sum of Rs.2178.14 lakh as 3rd installment in its letter No. F.No.59(4) PF-1/009/725 dated 27.3.2010 which was earlier approved in the 76th CSMC dated: 1.6.2010 accordingly, details of releases to be made release now by GOTN are detailed below:
