**ORDER:**

In the Government Order first read above, the Government have issued orders declaring the Thisayanvilai Town Panchayat area as the Thisayanvilai Local Planning Area under sub-section (4) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972). In the Government order second read above, the Government have declared the Thisayanvilai Town Panchayat as the Thisayanvilai Local Planning Authority for the Thisayanvilai Local Planning Area.

2. The Director of Town and Country Planning in his letter third read above, has stated that the master plan for the Thisayanvilai Local Planning Area has been prepared, taking into consideration, the current developments and also future developments and has requested the Government to give consent to the Local Planning Authority to the publication of a notice of the preparation of the master plan for the Thisayanvilai Local Planning Area.

3. In exercise of the powers conferred by sub-section (2) of section 24 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby gives his consent to the Thisayanvilai Local Planning Authority to the publication of a notice under section 26 of the said Act, of the preparation of the master plan for the Thisayanvilai Local Planning Area.

4. The draft master plan for the Thisayanvilai local planning area, as consented to by the Government under sub-section (2) of section 24 of the said Act, is returned to the Director of Town and Country Planning, and he is requested to acknowledge the receipt of the same. The Director of Town and Country Planning is directed to ensure that various provisions in the Tamil Nadu Town and Country

Planning Act, 1971 (Tamil Nadu Act 35 of 1972) and the Master Plan (preparation, publication and sanction) Rules, are strictly adhered to by the local planning authority before the master plan is resubmitted to the Government for their approval under section 28 of the said Act.
