ORDER

In the Government order first read above, orders were issued to take over the outstanding loans of the Tamil Nadu Water Supply and Drainage Board payable to LIC and TUFIDCO, by the Government and that the principal and interest be serviced by the Government with effect from 01.04.2005.

The Chairman and Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter fifth read above, has stated that in the G.O. first read above, the Government have taken over the outstanding loans of Tamil Nadu Water Supply and Drainage Board to the tune of Rs.18,126.02 lakhs payable to TUFIDCO for implementation of Rural Water Supply Scheme and that the principal and interest would be serviced by the Government with effect from 01.04.2005. Accordingly, the Demand for the quarter ending 31.03.2010 for the above loan (Principal amounting to Rs.5,14,72,000/- and interest amounting to Rs.1,71,09,997/-) is Rs.6,85,81,997/-. The Chairman and Managing Director, Tamil Nadu Water Supply and Drainage Board has requested the Government to make necessary arrangement to remit the above demand amount of Rs.6,85,81,997/- to TUFIDCO by means of crossed cheque drawn in favour of "Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited".

3. The Government after careful examination, accord sanction for the release of Rs.6,85,81,997/- (Rupees six crores eighty five lakhs eighty one thousand nine hundred and ninety seven only) towards repayment of principal and payment of interest amount due to TUFIDCO for the quarter ending 31.03.2010 in respect of loan obtained by Tamil Nadu Water Supply and Drainage Board for Rural Water Supply Schemes.
