ORDER:

In his letter the Director of Municipal Administration has stated that in G.O. (Ms) No. 521 /Municipal Administration and Water Supply Department / dated 30.3.2009 the Government have ordered that the new consolidated Government loan as on 1.4.2007 shall be payable by the Urban Local Bodies in 4 annual installments commencing from the year 2008 – 2009 for which Government will sanction Grants-in-Aid equal to the amount payable by the Urban Local Bodies. Accordingly, in the said G.O. itself, Government had also sanctioned an amount of Rs. 163,67,66,584/- as Grants-in-Aid to the Urban Local Bodies towards the repayment of the first annual installment of the new consolidated Government loan.

2. The Director of Municipal Administration has further stated that in the B.E, 2009-10, the Government have made an allocation of Rs. 150,00,00,000/- (Rupees one hundred and fifty crores only) as Grants-in-Aid to the Urban Local Bodies towards the repayment of the second annual installment of the above said loan.

3. The Director of Municipal Administration has therefore requested the Government to sanction a sum of Rs. 150,00,00,000/- (Rupees one hundred and fifty crores only) as Grants-in-Aid to the Urban Local Bodies as indicated in the Annexure to this G.O. towards the repayment of second installment amount of New Consolidated Government Loan (as on 31.03.2007) due by the Urban Local Bodies. The amount so sanctioned will be remitted to Government in the relevant head of account by contra credit.

4. The Government after careful examination, accept the proposal of the Director of Municipal Administration and sanction and release of Rs. 150,00,00,000/- (Rupees one hundred and fifty crores only) as Grants –in-Aid to the Urban local Bodies as indicated in the Annexure to this order towards the repayment of second installment of the New Consolidated Government Loan (as on 31.03.2007) due by the

Urban Local bodies. The amount so sanctioned shall be remitted to Government in the relevant head of account by contra credit.

5. The amount sanctioned in para 4 shall be debited to the following head of account:-

"2215 - Water Supply and Sanitation - 01 Water Supply - 191 Assistance to Municipal Corporations - Schemes in the Eleventh Five Year Plan - II State Plan - JX Grants in Aid to towards amount due by Municipalities for repayment of Consolidated Loans", - 09. Grants -in-aid - 04. Grants for debt servicing.

6. The Director of Municipal Administration is authorized to draw the amount sanctioned in para 4 above and to adjust the sum of Rs. 150,00,00,000/- by contra credit to the following head of account towards the repayment of second installment of the New consolidated Government loan dues by the concerned Urban Local Bodies as on 31.3.2007:-

"6215- Loans for Water Supply and Sanitation - 01 Water Supply 191 - Loans to Local Bodies Municipalities etc., I- Non plan - AK - Consolidated loans to Municipalities/Municipal Corporations except Chennai Corporation -01-Loans to Municipalities/Municipal Corporations except Chennai Corporation".
