**ORDER:**

In the letter read above, the Director of Municipal Administration has stated that the DPR prepared by Tamil Nadu Water Supply and Drainage Board received from Municipal Commissioner, Chidambaram for implementation of Water Supply Improvement Scheme in Chidambaram Municipality at a cost of Rs.7.42 crores was placed before the 5<sup>th</sup> State Level Sanctioning Committee Meeting held on-9.2.2009 and the project was approved for Rs.6.156 Crores and the minutes of the meeting was forwarded to the Government of India by the Nodal Agency(M/S.Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited).

2. The Director of Municipal Administration has also stated that the Chidambaram Municipality is a Selection Grade Municipality with an extent of 4.80 sq.km. and the population as per 2001 census is 57,733, TWAD Board have prepared the DPR and placed before the 5<sup>th</sup> SLSC meeting and got cleared for Rs. 6.156 crores. The details of the funding pattern of the proposed scheme as follows:-
