ORDER:

The Director of Municipal Administration, in his letter first read above has stated that the length of 3356.14 km. of earthen / WBM roads have been identified in the survey of roads in the urban local bodies. He has further stated that the Government have taken a view to convert the earthen / WBM roads into Black Topped / Cement Concrete Roads over the next four years starting from 2006-2007 and during the last three years, under various schemes, 1318.453 km earthen road has been proposed for the conversion into Black topped / Cement Concrete roads so far. Now the Director of Municipal Administration has proposed to take up the conversion of 67.70 km long earthen road at a cost of Rs.10 Crores in 59 Urban Local Bodies and requested the Government to sanction Rs.10 Crores under Part-II Scheme for the year 2009-2010 for the conversion of roads in 59 Urban Local Bodies as in the annexure. The State Planning Commission and the Standing Finance Committee have approved the Scheme.

2) The Government, after careful examination, accept the proposal of the Director of Municipal Administration and sanction a sum of Rs.1000.00 (Rupees one thousand lakhs only) as grant for conversion of 67.70 km of Earthen Roads into Black topped / Cement Concrete roads in 59 Urban Local Bodies as mentioned in the annexure to this order, under Part -II Scheme for the year 2009-10.

3) The amount sanctioned in para 2 above shall be debited to the following head of account :-

2217 - Urban Development - 05 Other Urban Development Schemes - 192. Assistance to Municipalities / Municipal Councils Schemes in the Eleventh Five Year Plan - II. State Plan - JJ. Conversion of earthen road into BT / CC roads in Urban Local Bodies - 09. Grants in Aid - 02. Grants for Capital Expenditure (2217 05 192 JJ 0928)

4) The Director of Municipal Administration is authorised to draw and release the amount sanctioned in para 2 above in 3 instalments, i.e., 15% as start up advance may be released now. The balance 85% may be released in 2nd and 3rd instalments (i.e) 35% based on the project approval by the concerned Municipalities / Municipal Corporations and 50% on completion of works respectively. The Director of Municipal Administration is also requested to send the Progress Report to Government.
