MEMORANDUM

Sub: Establishment –Tamilnadu Municipal Engineering Service – Assistant Executive Engineer (Municipal Engineer Grade-II) – Provisional Seniority list of Assistant Executive Engineer –(Municipal Engineer Grade-II) –working in Municipalities and O/o the CMA Communicated - confirmed seniority list communicated.

In this office memorandum cited, the provisional seniority list of Assistant Executive Engineer (Municipal Engineer Grade-II) was communicated to all the concerned with the direction to submit their representation if any regarding the seniority list within 30 days from the date of issue of that memorandum. Same was hosted on the website of Commissioner of Municipal Administration office i.e. [http: municipality. tn.gov.in/cma](http://municipality.tn.gov.in/cma). Some of the Assistant Executive Engineer (Municipal Engineer Grade-II) had represented to re-fix their seniority considering their objections raised by them. *Marked officers have raised certain claims / objections/ suggestions and their representation have been scrutinized as follows:

1) Tvl. T. Manohara Chandran (Seniority list.No.8) , P.Thangamony (Seniority list.No. 10), A.Sethu Ravanth (Seniority list.No.17), J. Balasubramanian (Seniority list.No.22), R.Mani (Seniority list.No.23) , B.Ramamoorthy (Seniority list.No.25), R.Chinnadurai (Seniority list.No.26), A.Kanagaraj (Seniority list.No.29), K.Murugesan (Seniority list.No.32), R.Vasudevan (Seniority list.No.35), A.Ramamurthy (Seniority list.No.39), J.Alponse (Seniority list.No.55), A.Gurusamy (Seniority list.No.57) and T. Rajakumaran (Seniority list.No.79) have requested to re-fix his name as per present TNMES Rules 1997.

Above mentioned officers had made their representations during earlier occasion also and their representations were examined at earlier also. Their representation were not accepted by the Commissioner of Municipal Administration as well as Government. Meantime these officers have approached Hon'ble High Court and W.P. is pending with the Hon'ble High Court for disposal. As their claim is now under judicial / legal scrutiny, their claim would be considered on the basis of the outcome of the W.P.

2) Thiru.K.Ravi, Avadi (Seniority list No.11) has requested to re-fix his seniority as above Thiru. P. Thangamony and below N. Punniamurthy with reference to date of joining duty. Thiru. P.Thangamony is senior to him in the feeder category of JE as such the seniority fixed in this office memo is in order.

3) Thiru. Ruban Suresh Ponniah, Tiruvottiyur (Seniority list No.13) has requested to fix his seniority with ref. to date of joining in the post of AEE. There is no provision to fix seniority with ref. to date of joining. Hence his request is not considered.

4) Thiru. S.Venkatesh ,AEE, (Seniority list No.14) Salem Corporation has requested to correct his date of joining and Education Qualifications as ME.(Environment Engnn). His request is accepted.

5) Thiru. M.Ramasamy, Attur (Seniority list No.24) has requested to re-fix his seniority in S.No.12, instead of S.No.24, as per TNMES Rules 1997 (G.O.310, dt.24.12.1997). Seniority has been fixed only with reference to TNMES Rules 1997 only. His interpretation in respect of TNMES Rules is not correct. Hence his claim is not considered.

6) Thiru. G. Karunkaran, AEE, (Seniority list No.27) Srivilliputhur Municipality has requested to change his date of birth as 16.06.1959 and educational qualification as DCE. His request is accepted .

7) Thiru. K. Subas Bose, DTP (Seniority list No.37) has requested to re-fix his seniority as below Thiru K.Lakshmanan and above Thiru G.Karunakaran with ref. to Date of appointment in the post overseer / JE. He has been promoted as AEE only in 2005.Now the seniority fixed with reference to prevailing TNMES rules 1997. As such the request of the individual is not considered.

8) Thiru. V.Jagadeesan , DTP (Seniority list No.38)has requested to re-fix his seniority as Sl.NO.26 instead of Sl.No.38 as per TNMES Rules. Further his date of birth should be as 31.1.1957 instead of 1.9.1962. Seniority has been fixed only with reference to TNMES Rules 1997 only. His interpretation in respect of TNMES Rules is not correct. Hence his claim is not considered. Date of birth is corrected as 31.1.1957

9) Thiru. N.Ameenur Rahman, DTP (Seniority list No.47)has requested to re-fix his seniority as next to Thiru. S.Sundaramoorthy including his name in previous year panel. Promotion was given after following the rules and regulation prevalent at that time. Seniority has been fixed as per TNMES 1997 rules only. Hence his request is not considered.

10) Thiru.P.R. Muralidharan, DTP, (Seniority list No.54) has stated that his name may be included in the AEE panel for 2003-04. His name should be placed in between Thiru G.Ranadev & Thiru S.Murugan. since no charges were pending at that time. As the individual was undergone punishment of Censure on the crucial date 15.3.2003 his name was not considered for the panel year 2003-04. Hence his request is not considered.

11) Thiru. D.Chandrasekaran, AEE, Karaikudi Municipality (Seniority list No.50) has requested to change his date of birth as 16.06.1959 and educational qualification as DCE. His request is accepted.

12) Thiru.S. Mani, Palani Municipality (Seniority list No.56) has requested to refix his name as per G.O.176, MA&WS, Dept., dt.31.5.2006 in between Sl.NO.54 Thiru. K.Manivel and Thiru.J. Alphones S.No.55. Based on his appeal Govt.in G.O.(D) No.176,MA&WS,dept.,dt.31.5.2006 have ordered to fix his name below thiru.K.Manivel above Thiru.J. Alphones in the panel approved for the year 2004-2005. Hence his request is accepted.

13) Thiru. B.Khader Mohideen, Virudhunagar (Seniority list No.73) has requested to refix his name in EE Panel. since he has obtained Higher Educational qualification. There is no provisions in the Service rules to promote the person who possess higher qualification than the required minimum qualification without following the seniority other criteria prescribed in the rules. Hence his request is rejected.

14) Thiru.G. Srinivasan, O/o the C.M.A. has requested to refix his seniority with ref. to date of appointment in the post of Overseer and without adopting 3:1 ratio for the post of AEE from 1982 to 24.12.1997. He has submitted appeal after lapse of 16 years moreover Govt. in letter No.38679/ME3(1), 2005-3, MAWS., Dept., dt.19.4.2006 has informed that the request of the CMA to regularise the services of the temporarily promoted AEEs from 1988 to 24.12.97 without adopting 3:1 ratio can not be accepted. As such the seniority fixed with ref. to TNMES rules is in order.

15) Thiru. N.Mahesan, Alandur has requested to consider his service in Chennai Corporation (5 years) as AEE from 1996 to 2001 as to fix seniority in the post of AEE as 34 (1) below the name of Thiru A.Francis Selvaraj. He has gone on deputation to Chennai Corpn. as Assistant Engineer and on own request got promotion to fill up the vacancies in Chennai Corporation and returned back as AE only. Hence period of service rendered in the other corpn. can not be taken into account for seniority in the Municipal Engineering Services. Hence his request is not considered.

Almost all the objections received for the alteration of the seniority of the persons promoted as AEEs during the year 1988 to 24.12.1997 (i.e. till the issuance of the Tamil Nadu Municipal Engineering Service Rules.) In this connection it is informed that there was no post of AEE in Municipalities up to the year 1982. After that a few posts were created under Self Sufficiency Scheme and that posts were filled up from the post of JE Gr. I / ME. Gr.III with reference to date of appointment as ordered by the Government. After that, Government in G.O.Ms.No.1021, MAWS., Department, dated 5.12.1988 have ordered to follow 3:1 (i.e. 3 Degree holder and 1 Diploma holder) for the promotion of AEE in future, since the system was prevalent in PWD and Highways Departments. Accordingly promotions were made

temporarily. Subsequently Government in G.O.310, MAWS., Dated 24.12.1997 have issued service rules. But there is no mention about 3:1 ratio for promotion to the post of AEE in the service rules. Further in Rule 8 it is described that (Saving clause) "Nothing contained in these rules shall adversely affect any person holding any of the posts referred to in these rules on the date of coming into force of these rules. So this protection is applicable to the all persons who were promoted as AEE prior to 24.12.1997. All the services were regularised based on the clarifications issued by the Government in letter Roc.No.38679/ME-3(1)/2005-3, dated 19.4.2006

Further Thiru B.Ramamoorthy and 14 others had filed a Writ No.36353/2005/ and 39225/2005 to alter the seniority and the High Court passed order to consider their representation. As such their claims were examined with ref. to rules and their claims were rejected, and the fact was also informed to the Hon'ble Court. Further Thiru A. Sethu Ravanth, AEE and others have filed a writ petition No.8469/2006 to quash the Executive Engineers panel approved in G.O. (2D) No.13, MAWS., Department, dated 1.3.2006 which was drawn following the existing rules and regulations The High Court in its order dated 3.4.2006 has passed interim order that any posting given pursuant to the impugned panel shall be subject to the final order in the writ petition. Now the post of Executive Engineers are being filled with that conditions only.

Hence the provisional seniority list already communicated in this office memo Ist cited is confirmed as found in Annexure with certain modification and subject to the outcome of the W.P.No.8469/2006, which is pending in the High Court.

The Municipal Commissioners shall ensure that the final confirmed seniority list is communicated to the concerned Assistant Executive Engineers.

The receipt of this memorandum should be acknowledged by return of post.
