His claim is found to be true on the basis of his day of joining.

2) M.Panneerselvam, (Sl.No.51), Palani, has requested to change his joining date as Overseer and place his name before Nagarajan. formerly Overseer, Krishnagiri now in DTP placed in the Sl.No.50 is accepted.
