The Director of Town Panchayats in his letter read above has stated that a sum of Rs.8400.07 lakh as basic grant and Rs.5764.76 lakh as performance grant has been allocated under 13th Finance Commission in respect of Town Panchayats in the Budget Estimate for the year 2012-2013.

2. The Director of Town Panchayats has therefore requested the Government to release a sum of Rs.42,00,03,500/- as basic grant and Rs.28,82,38,000/- as performance grant as first instalment of 13th Finance Commission grant for the year 2012-2013.

3. The Government, after careful examination of the proposal of the Director of Town Panchayats, sanction and release a sum of Rs.42,00,03,500/- (Rupees Forty two crore three thousand and five hundred only) as basic grant as first instalment of 13th Finance Commission grant for the year 2012-2013.

4. The amount sanctioned in para 3 above shall be debited to the following head of Account:-

“3604-00 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions – 193 – Assistance to Nagar Panchayats / Notified Area Committees or equivalent thereof – II State Plan – JD – Grants to Town Panchayats as per the recommendations of 13th Finance Commission Controlled by Director of Town Panchayat – 09 – Grants-in-aid-01 Grants for Current Expenditure.
