ORDER:-

While moving the demand No.34, on 09.04.2012 the Hon'ble Minister (Municipal Administration and Rural Development) has announced that the Office buildings for Pennathur, Panamarathupatti, Arakandanallur, Pannaikadu, Chettipalayam, Pallappalayam, Perundurair, Vengambur, Kamuthi, Sayalkudi, Kalakkadu, Thirukkurungudi, Pathamadi, Thisaiyanvilai, Aralvoimozhi Town Panchayats at a cost of Rs.6.00 crore and Tirunelveli Zone, Office of the Assistant Director of Town Panchayats will be constructed at a cost of Rs.1.00 crore during the year 2012-2013.

2. Pursuant to the announcement, the Director of Town Panchayats has sent necessary proposal for construction of Office buildings to 15 Town Panchayats and Office of the Assistant Director of Town Panchayats, Tirunelveli Zone at a total cost of Rs.7.00 crore.

3. The Government, after careful consideration of the proposal of the Director of Town Panchayats, accord administrative sanction for a sum of Rs.7,00,00,000/- (Rupees seven crore only) and also accord financial sanction for the year 2012-2013 for a sum of Rs.3.50,00,000/- (Rupees Three Crore and Fifty lakh only) to the Director of Town Panchayats as first installment for construction of Office buildings for 15 Town Panchayats and Office of the Assistant Director of Town Panchayats, Tirunelveli Zone as mentioned in the annexure. The balance amount of Rs.3.50 crore will be released in 2013-2014 based on progress of works.

4. The amount sanctioned in para 3 above shall be debited to the following head of Account:-

“4515-00- Capital outlay on other Rural Development Programme – 800- Other Expenditure – Schemes in Twelfth Five Year Plan – II- State Plan- JW – Construction of Office Buildings for Town Panchayats – 16- Major works”.
(DPC- 4515-00-800-JW-1608)

5. The expenditure sanctioned in para - 3 above shall constitute a “New Instrument of Service”. The expenditure shall be brought to the specific notice of the Legislature for approval in due course. Pending approval of the Legislature, the expenditure shall be met initially from a Contingency Fund Advance. The **Director of Town Panchayats** is requested to apply for the required funds from Contingency Fund to the Finance (BG-I) Department in the prescribed format along with a copy of this order. The Director of Town Panchayats is requested to send necessary proposal to include this expenditure in the Supplementary Estimates 2012-2013, without fail.
