ORDER:

In his letter read above, the Director of Ex-Servicemen's Welfare has stated that at the XIV Meeting of the Kendriya Sainik Board held at New Delhi on 29.10.1980, the State Governments were requested to reserve certain percentage of Industrial Plots, sheds / shops in the Industrial Complexes for Ex-Servicemen in order to resettle them in self-employment. As there is no reservation of Industrial plots / sheds in the Industrial Complexes for Ex-Servicemen in this State at present, the Director of Ex-Servicemen's Welfare has requested the Government to reserve certain percentage of Industrial plots / sheds for Ex-Servicemen in the existing, Industrial Complexes in Tamil Nadu.

2. The Chairman and Managing Director, Tamil Nadu Small Industries Development Corporation Limited in his letters read above has stated that small gestures such as reservation of certain percentage of sheds / plots for allotment to Ex-Servicemen is considered as quite necessary. The Board of Directors of Tamil Nadu Small Industries Development Corporation Limited at the 72nd Meeting held on 24/06/1981 has resolved to reserve upto 10% of the sheds / plots in the Industrial Estates / Developed plot estates at the time of every allotment, for ex-servicemen provided there are enough number of eligible applicants who have taken financially viable and technically feasible projects and have taken necessary steps for obtaining term loans, getting machinery raising their equity etc.

3. The Government after careful consideration accord the proposal of Tamil Nadu Small Industries Development Corporation Ltd. and direct that upto 10% of the sheds / plots in the industrial estates / developed plot estates be reserved at

the time of every allotment for ex-servicemen provided there are enough number of eligible applicants who have who have take financially viable and technically feasible projects and have taken necessary steps to obtain term loans, getting machinery raising their equity etc. The Government also direct that the reservation will not be carried over and the above orders will be given effect to in future while making allotment of shed / plots in the industrial estates and development plot estates.
