ORDER

The Government of Tamil Nadu have issued orders in the G.O. first read above that the backlog / shortfall vacancies of SC and ST shall be filled up by direct recruitment in the lowest level of posts in Groups A, B, C, D in order to make good the inadequate representation of the SC/STs. However it was ordered in Government Letter No.15684/TDL.2/98-8, Adi Dravidar & Tribal Welfare Dept dt.28.7.2000 that no further action need be pursued with regard to G.O.Ms.No.44, Adi Dravidar & Tribal Welfare Dept dt.20.5.98. The Govt in G.O.(Ms) No.91, Adi Dravidar & Tribal Welfare Dept dt.28.11.2001 have restored the orders in G.O.(Ms) No.44, , Adi Dravidar & Tribal Welfare Dept. dt.20.5.98.

2. The Govt after identifying the shortfall vacancies in certain categories on different services, have examined the issuance of special notification as ordered in G.O.(Ms) No.2, , Adi Dravidar & Tribal Welfare Dept dt.2.1.97. The Chairperson, Tamil Nadu Public Service Commission has opined that the backlog vacancies of SC/STs can be filled up by Special Notification as provided under General Rule 22 of the Tamil Nadu State and Subordinate Services Rules. However, no separate provisions are available in the said Rules for filling up of the shortfall SC/ST vacancies. Hence the Tamil Nadu Public Service Commission can make direct recruitment against the shortfall vacancies of SC/ST after making provisions under General Rule 22 of the Tamil Nadu State and Subordinate Services Rules, relating to Rule of Reservation. The Govt have constituted a High Level Committee in G.O.(Ms) No.138, , Adi Dravidar & Tribal Welfare Dept dt.8.11.2006 to examine the issues relating to the filling up of shortfall vacancies. The said Committee after consideration have recommended that the General Rule 22 of Tamil Nadu State and Subordinate Services Rules may be amended so as to incorporate the provision for filling up of shortfall vacancies of SC/STs by direct recruitment through the recruitment agencies.

3. The Govt accordingly direct that the shortfall vacancies of SC/STs in the lowest level of posts in each Group A, B, C, D may be filled up as per the orders issued in the Government order third read above through the recruiting agencies by direct recruitment for which the General Rule 22 of the Tamil Nadu State and Subordinate Services Rules be amended suitably.

4. Necessary amendment to General Rule 22 of the Tamil Nadu State and Subordinate Services Rules will be issued separately by the Personnel & Administrative Reforms Department in consultation with the Tamil Nadu Public Service Commission.
