ORDER:

The Commissioner for Milk Production and Dairy Development has stated that the Co-operative Dairy Development, Sector is functioning at 3 levels, Milk Producers Cooperative Societies at Village level (Primary level) District Cooperative Milk Producers Union at District level and Milk Producers Cooperative Federation at State level and they are doing the same service of procuring the milk from milk producers. To make the Milk Producers Cooperative Societies sound in financial position, sale of milk and milk products should be increased. Hence provision of Softy Ice Cream & Paneer Making Machines and Kova pan are necessary.

2. The Commissioner for Milk Production and Dairy Development has proposed to provide the following items: -

The Commissioner for Milk Production and Dairy Development has proposed to procure the above items, to make the milk producers Co-operative Societies sound in financial position and to increase sale of milk and milk

products at a total cost of Rs.3.50 lakhs (Rupees three lakhs and fifty thousand only) under Part II Scheme for the year 2008-09.

3. After careful examination, the Government accept the proposal of the Commissioner for Milk Production and Dairy Development and accordingly sanction a sum of Rs.3.50 lakhs (Rupees three lakhs and fifty thousand only) under Part-II Scheme for the year 2008-2009 for Provision of Softy Ice Cream, Gova and Paneer Making Machine.

4. The amount sanctioned in para 3 above shall be debited to the following head of account: -

The Commissioner for Milk Production and Dairy Development and the Managing Director, Tamil Nadu Co-operative Milk Producers' Federation Limited are requested to follow the tender procedure laid down in the Tamil Nadu Tender Transparency Rules, 2000. They are also requested to furnish the progress report in the implementation of the project to Government every month.
