ORDER:

The Commissioner for Milk Production and Dairy Development has stated that they are procuring 27.00 lakhs litres of milk from the Milk Producers and 23 Deputy Registrar (Dairying) offices are functioning at district level and Commissioner for Milk Production and Dairy Development as Head of the department at state level. In order to supervise the activities of Milk Producers and to implement various schemes of Government Computers, Xerox and Fax machines are necessary to execute communication effectively. Hence, all 23 Deputy Registrar (Dairying) offices at District level and Commissioner for Milk Production and Dairy Development have to be provided with computers, Xerox and Fax machine.

2. The Commissioner for Milk Production and Dairy Development has therefore proposed to purchase 12 computers, 1 Fax machine, 1 Copier and 1 Xerox machine to Commissioner for Milk Production and Dairy Development at a total cost of Rs.7.50 lakhs (Rupees seven lakhs and fifty thousand only) under Part-II Scheme for the year 2008-09.

3. After careful examination, the Government accept the proposal of the Commissioner for Milk Production and Dairy Development and accordingly sanction a sum of Rs.7.50 lakhs (Rupees seven lakhs and fifty thousand only) under Part-II Scheme for the year 2008-2009 for purchase of Computers and accessories, Xerox and Fax machines for the office of the Commissionerate of Milk Production and Dairy Development.

4. The amount sanctioned in para 3 above shall be debited to the following head of account: -

5. The Commissioner for Milk Production and Dairy Development is authorized to draw and incur the amount sanctioned in para 3 above and execute the work as per tender procedure. The Commissioner for Milk Production and Dairy Development is also requested to furnish the progress report in the implementation of the project to Government every month.
