



Abstract

Fisheries – Centrally Sponsored Scheme of reimbursement of Central Excise Duty on High Speed Diesel Oil supplied to the Mechanised fishing boats below 20 meter length – Sanction of Rs.2,59,00,000/- during 2006-07- Orders – Issued.

ORDER:

In the letter first read above, the Government of India have conveyed their administrative approval for the payment of Rs.2,59,00,000/- (Rupees two crores fifty nine lakhs only) towards 80% central share of grant-in-aid for rebate on High Speed Diesel Oil consumed by the mechanized fishing vessels below 20 meter length during 2006-07 subject to certain conditions.

2. The Director of Fisheries has requested the Government to sanction an expenditure of Rs.3,23,75,000 (Rupees Three cores twenty three lakhs and seventy five thousand only) towards the payment of Fishermen Development rebate on High Speed Diesel Oil for the year 2006-07 on 80:20 basis i.e. 80% Central share and 20% State share. However in the sanction letter from Government of India is stated where sales tax of HSD is exempted for the mechanized boats 100% cost will be borne by Government of India.

3. The Government after careful consideration accord sanction for payment of Rs. 2,59,00,000/- (Rupees two crores fifty nine lakhs only) towards grant-in-aid for reimbursement of Central Excise Duty on High Speed Diesel Oil supplied to the Mechanised fishing boats below 20 meter length during 2006-07.

4. The expenditure sanctioned in para 4 above shall be debited to:

"2405-00-Fisheries-800 Other expenditure - Schemes in the Xth Five year Plan-VI Schemes shared between State and Centre - UC. Assistance to fishermen for purchase of diesel-11 subsidies-01. Individual Based subsidy."

The amount sanctioned in para 4 above shall not be paid in cash but shall be by per contra credit Under the following Head of Account:

"K.Deposits and Advances (b) Deposits - Non bearing interest 8443-00-Civil Deposits - 106. Personal Deposits"

5. The Director of Fisheries shall send utilization certificate clearly and specifically indicating that the sanctioned amount has been utilized for the scheme without deviation from the above norms of the Government of India. The unspent balance if any shall be surrendered to the Government.

6. The Director of Fisheries shall give an account about the total quantity of High Speed Diesel Oil sold and the subsidy allowed separately in due course to Government. He shall also reconcile the balance amount available out of the grant sanctioned for previous years and send a detailed report to Government of India.

7. The Director of Fisheries is permitted to draw the amount sanctioned in para 3 above and to deposit the amount with the Special Officer Tamil Nadu State Apex Fisheries Co-operative Federation Limited Chennai.

8. This order issues with the concurrence of Finance Department vide its U.O.No.1093/FS/P/2007, dated 29.3.2007.
