Part II Scheme for 2007-2008 – Construction of a new godown at Gudiyatham in Vellore District – Financial Assistance – Sanctioned – Orders – Issued.

ORDER:

As the private godowns taken on rent are mostly unscientific buildings and are prone to heavy expenditure by way of storage losses operational godowns are constructed in Taluks in a phased manner by the Tamil Nadu Civil Supplies Corporation Ltd.

2. The Chairman and Managing Director, Tamil Nadu Civil Supplies Corporation Ltd. has sent a proposal for construction of an operational godown at Gudiyatham with 1500 MT capacity in an area of 987 square meters (10,620 Sq.ft.) at an estimated cost of Rs. 35 lakhs with all amenities under Part II Scheme for the financial year 2007-2008.

3. The Government after careful examination, accept the proposal of the Chairman and Managing Director, Tamil Nadu Civil Supplies Corporation Ltd. for construction of godown at Gudiyatham Taluk, Vellore District at an ultimate cost of Rs. 35.00 lakhs and cost during the year Rs. 14.00 lakhs and they accordingly sanction an expenditure of Rs. 14 lakhs (Rupees Fourteen lakhs only) towards construction of godowns at Gudiyatham for additional space to cater the needs for operational work area for weighing standardization and storing of gunnies.

4. The Principal Commissioner and Commissioner of Civil Supplies and Consumer Protection is authorized to draw and disburse the amount to the Chairman and Managing Director, Tamil Nadu Civil Supplies Corporation Ltd. by an account payee cheque.

5. The expenditure sanctioned in para 2 above shall be debited to the following head of account.
