ORDER:-

The Government have proposed to introduce mechanical conveyor systems for unloading, stocking and reloading arrangements for grain bags inside the godown campus at Anna Nagar, Chennai. Accordingly, the Chairman and Managing Director, Tamil Nadu Civil Supplies Corporation Ltd. has sent a proposal for providing mechanical conveyor system in godowns at Anna Nagar at a total cost of Rs. 25 lakhs under Part II Scheme for the Financial Year 2007-2008.

The Government after careful examination, have accepted the proposal of the Chairman and Managing Director, Tamil Nadu Civil Supplies Corporation Ltd. for providing Mechanical Conveyor System at Anna Nagar Godown campus, Chennai under Part II Scheme for the year 2007-2008 and they accordingly sanction an expenditure of Rs. 25 lakhs (Rupees Twenty five lakhs only) towards providing Mechanical Conveyor System at Anna Nagar godown of Tamil Nadu Civil Supplies Corporation Ltd. at Chennai for increasing the loading speed and reducing the waiting time of lorries and congestion of lorry parking.

3. The Principal Commissioner and Commissioner of Civil Supplies and Consumer Protection is authorized to draw and disburse the amount to the Chairman and Managing Director , Tamil Nadu Civil Supplies Corporation Ltd. by an account payee cheque.

4. The expenditure sanctioned in para 2 above shall be debited to the following head of account.
