ORDER:

There have been some complaints from the general public about underweighting of essential commodities supplied by the fair price shops. In order to ensure correct weighing of commodities distributed in the fair price shops, the Registrar of Cooperative Societies has proposed that modern weighing machines may be provided to the fair price shops run by the cooperatives.

2. The Government have carefully examined the proposals and they consider that all the fair price shops run by the cooperatives should be provided with modern weighing machines so that the correct quantity of essential commodities may be supplied to the cardholders. Accordingly the government sanction a sum of Rs.11.50 crores (Rupees eleven crores and fifty lakhs) towards financial assistance in the form of subsidy to Cooperative fair price shops for purchase of 23,600 modern weighing machines for the fair price shops run by the cooperative societies under part II scheme for the year 2007-2008. The procedures laid down in the transparency in Tenders Act shall be followed for procuring the machines.

3. The Joint Registrar of Cooperative Societies (Consumer Cooperatives), Office of the Registrar of Cooperative Societies is authorized to draw and disburse the amount to the Tamil Nadu State Apex Cooperative Bank, for being passed on to the concerned cooperative societies through the concerned District Central Cooperative Banks.

4. The expenditure shall be debited to the following head of account:
