**ORDER**

The Tamil Nadu News Print and Papers Ltd., have requested the Principal Chief Conservator of Forests to allot them 3,00,000 M.T. (3 lakhs) of pulp wood for the year 2007-2008 since they have increased the capacity of paper production.

2. In the letter read above, the Principal Chief Conservator of Forests has stated that a quantity of 7864.308 M.T. of Eucalyptus Hybrid wood is available from outside the forest areas in plains (Social Forestry areas) to be allotted to users industries for the year 2007-2008. He has requested the Government to consider to allot the quantity of 7864.308 M.T. or 7800 M.T. of Eucalyptus Hybrid pulpwood available from Social Forestry plantation raised outside forest areas in plains to Tamil Nadu News Print and Papers Limited for the year 2007-2008 at the rate of Rs.1800/- (Rupees One thousand and eight hundred only) plus 5% administrative charges subject to usual terms and conditions.

3. The Government after careful consideration of the proposal of the Principal Chief Conservator of Forests have decided to accept his recommendation to allot 7800 M.T. of Eucalyptus Hybrid pulp wood available from Social Forestry Plantation raised outside forest areas in plain to Tamil Nadu News Print and Papers Limited for the year 2007-2008 at the rate of Rs.1800/- (Rupees One thousand and eight hundred only) initially subject to the condition that the Tamil Nadu News Print and Papers Limited shall pay the balance cost after the final rate is fixed by the Government and with usual terms and conditions.
