ORDER:

The proposal for maintenance and black topping of Forest road from Kaveripatti to Karuppampatti at Trichy District to a distance of 2.60 Kms. at a cost of Rs.36.00 lakhs was considered under Part-II Schemes for the year 2007-2008. The Standing Finance Committee has given concurrence to the proposal of the Principal Chief Conservator of Forests under Part-II Scheme 2007-2008 for maintenance and black topping of Forest roads Kaveripatti to Karuppampatti at Trichy District to a distance of 2.60 Kms. at a cost of Rs.36.00 lakhs (Rupees Thirty six lakhs only)

2. The Government after careful examination, sanction an expenditure of Rs. 36.00 lakhs (Rupees Thirty six lakhs only) for improvement of Forest road from Kaveripatti to Karuppampatti at Trichy District to a distance of 2.60 Kms. during 2007 -2008, under Part-II Schemes 2007-2008.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account::

4. The Principal Chief Conservator of Forests is authorized to draw and incur the amount and he is requested to ensure that the amount sanctioned for the above road work is utilised in full during 2007-2008 and to send utilization certificate to Government as soon as the work is completed.
