ORDER:

The Director of Environment has reported that to create environmental awareness among the school and college students, 1200 eco clubs have been formed in all the districts of the State involving selected educational institutions and Non Governmental Organisations. Environmental exhibitions are conducted every year at District level through the Eco-clubs. Financial assistance to the extent of Rs.50,000/- per district is released for the activities of the Eco-clubs every year. Each District has got Eco-clubs in 40 schools. The Director of Environment has stated that the financial assistance of Rs. 50,000/- may be enhanced to Rs. 1.00 lakh on a par with Government of India's grant to National Green Corps @ Rs. 2500/- per school. The Director of Environment has sent a proposal for sanction of a sum of Rs.15.00 lakhs under Part II Scheme for 2007-2008, to meet the expenditure for creation of Environment Awareness through Eco –clubs.

2. The Government after careful consideration accept the proposal of the Director of Environment and accord sanction for a sum of of Rs. 15.00 lakhs (Rupees Fifteen lakhs only) under Part II Scheme 2007-2008 for creation of Environment Awareness through Eco –clubs.

3. The expenditure sanctioned in para 3 above shall be debited to the following Head of account.
