ORDER:

In the G.O. first read above, the Government have issued orders enhancing the entrance fee etc. for the visitors to the Arignar Anna Zoological Park,. Vandalur, Chennai.

2. The Principal Chief Conservator of Forests and Chief Wildlife Warden in his letter second above has sent proposal for enhancing the entry fee etc. to the visitors of Arignar Anna Zoological Park. The above proposal was placed before the 8th Governing Board Meeting held on 1.7.2008 and was approved by the Board.

3. The Government after careful consideration accept the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden and accordingly revise the entrance fee etc for admission in to the Arignar Anna Zoological Park, Vandalur as detailed below:-

4. The Director, Arignar Anna Zoological Park, Vandalur Chennai is authorised to levy the revised entrance fee etc as detailed in para (3) above in the Arignar Anna Zoological Park. Vandalur. The Government also direct that the entrance fee etc except the parking charges shall be revised with effect from 1.10.2008. As the parking area has been leased out to Private Contractor till 2.1.2009, the entrance rate for parking area will be revised after completion of lease period.
