#### ORDER:

In the Proceedings first to third read above, Administrators were appointed to K.H.108, Mampattu Devangar Handloom Weavers Co-operative Production and Sales Society Limited, Vellore Circle, for total period of three years with effect from 12<sup>th</sup> September 2001 to 11<sup>th</sup> September 2004 by the Director of Handlooms and Textiles under sub section (12) of section 33 of the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983).

2) In the letter eighth read above, for the reasons stated therein, the Director of Handlooms and Textiles has requested the

Government, to grant necessary exemption from the provisions of sub-section (12) of section 33 of the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983), for appointment of an Administrator to K.H.108, Mampattu Devangar Handloom Weavers Co-operative Production and Sales Society Limited, Vellore Circle, in exercise of the powers conferred by clause (a) of section 170 of the said Act, for a further period of three years with effect from the 12<sup>th</sup> September 2004 to 11<sup>th</sup> September 2007.

3) The Government, after careful examination, have decided to accept the request of the Director of Handlooms and Textiles. Accordingly, in exercise of the powers conferred by clause (a) of section 170 of the Tamil Nadu Co-operative Societies Act, 1983 (Tamil Nadu Act 30 of 1983), the Governor of Tamil Nadu, hereby exempts K.H.108, Mampattu Devangar Handloom Weavers Co-operative Production and Sales Society Limited, Vellore Circle, from the provisions of sub-section (12) of section 33 of the said Act, for a further period of three years with effect from the 12<sup>th</sup> September 2004 to 11<sup>th</sup> September 2007, so as to enable the Director of Handlooms and Textiles, to entrust the management of the affairs of the said society, to an Administrator, for a period of three years with effect from the 12<sup>th</sup> September 2004 to 11<sup>th</sup> September 2007, or till the elected Board assumes office, whichever is earlier.
