ORDER:

In the Government Order first read above, Government have provided a sum of Rs.200.00 lakhs towards rebate on sale of Khadi cloth to Tamil Nadu Khadi and Village Industries Board for the year 2007-2008.

In the circumstances explained by the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board, in the letter second read above the Government after careful examination accept request and accordingly sanction is accorded for a sum of Rs.1.00 crore (Rupees One Crore only) as an adhoc advance payment towards the grant of rebate on the sale of Khadi varieties effected by the Khadi Board for the year 2007-2008.

3. The expenditure sanctioned in para.2 above shall be debited to 2851.00 Village and Small Industries - 105 Khadi and Village Industries - I Non Plan - AL. Rebate on sale of Khadi cloth to Khadi Board - II. Subsidies - 02. General Subsidy.


