Order:

The Collector, Kancheepuram District has stated that 1.97 Acres of land in S.No. 52/2C2 etc., in Okkiam Thuraipakkam Village, Kancheepuram District were acquired for the formation of Radial Roads and handed over to Highways Department on 4.12.1999. The land owners refused to accept the compensation arrived by the department and preferred an appeal in the High Court for enhanced compensation. The compensation amount of Rs. 1,46,040.10 arrived by the Department was deposited in the Saidapet Sub- Treasury on 22.2.1988. Mean while, the appeal preferred by the land owners had been dismissed by the High Court and hence the Department has to pay the compensation amount due to the Land Owners . However, the Sub – Treasury Officer, Saidapet informed that the amount deposited in the Saidapet, Sub-Treasury was treated as lapsed deposit as on 1-4-1992 and revalidation orders have to be issued by the Government for release of the said deposit amount.

2. The Collector of Kancheepuram District has therefore requested for revalidation of the compensation amount of Rs.1,46,040. 10 deposited in the Sub-Treasury , Saidapet on 22.2.1988 . The Commissioner for Land Administration, Chennai has recommended the above proposal of the Collector, Kancheepuram. The

Chief Engineer (General), Highways Department has also recommended and requested the Government to issue necessary revalidation orders for payment of compensation to the landowners.

3) The Government have carefully examined the proposal of the Collector, Kancheepuram in para 2 above and accepted the same . The Government hereby order for the revalidation of the payment of compensation amount of Rs. 1,46,040.10 (Rupees one lakh fourty six thousand and fourty and paise ten only) which was deposited in the Sub Treasury, Saidapet towards compensation amount payable to the land owners of S.No. 52/2C2 etc., of lands measuring 1.97 acres acquired in Okkiyam – Thuraipakkam Village, Tambaram Taluk, Kancheepuram District towards formation of link road between NH 45 to Mahabalipuram, under Radial Roads scheme.
