ORDER:-

In the Government order first read above, orders have been issued for the levy of tolls on Vehicles entering the roads in Kodaikanal Municipal area in the Dindigul District for a period of one year beyond 14..6.2005.

2. In the letter third read above, the Collector of Dindigul District has sent proposals to permit him to collect tolls for the vehicles entering Kodaikanal Municipal area through the Ex servicemen for a further period of one year from 15-6-2006 as follows:-

4)	Tourist Car, Taxi (including Sumo, Qualis, Trax)	Rs. 30/- (Rupees thirty only)
5)	Car or Jeep	Rs. 20/- (Rupees twenty only)
6)	Maxi Cab (Van, Mini Lorry, Tractor,)	Rs. 50/- (Rupees fifty only)
7)	Three Wheeler and two wheelers	Rs. 10/- (Rupees ten only)

3. The Government after careful examination accept the proposal of the Collector, Dindigul in para 2 above and permit him / her to levy and collect tolls on vehicles entering the roads in the Kodaikanal Municipal area at the rates specified in the Notification appended to this order for a further period of one year from 15-6-06 through the Ex servicemen. The said levy of tolls will not be applicable for non -commercial vehicles owned by the residents of the Kodiakanal Municipal area..

4. The Collector, Dindigul is requested to send proposal to Government increasing the toll rates for the vehicles entering into the Kodaikanal Municipal area for the next year at the appropriate time.

5. The Notification appended to this order will be published in an Extra Ordinary issue of the Tamil Nadu Government Gazette dated 25 -7-2006.

6. The Collector, Dindigul District is also directed to take necessary further action for the levy of the toll with effect from 15-6-06 as per the rules issued in G.O. (Ms) No.3630 ,Local Administrative dated 1.12.1942 as subsequently amended.

NOTIFICATION

In exercise of the powers conferred by Clause (a) of Sub-Section (1) and Sub Section (2) of Section 2 of the Indian Tolls Act 1851 (Central Act VIII of 1851) , the Governor of Tamil Nadu hereby tolls for a period of one year with effect on and from the 15 th June 2006 on the classes of Motor Vehicles specified in Column (2) of the table below which pass through the Dindigul - Kodaikanal Road, Palani - Kodaikanal Road and Cochin - Kodaikanal road at silver cascade and next to Pillar rocks in between Pillar rock and Moyar point in Kodaikanal in Dindigul District at the rates specified in the corresponding entries in Column (3) thereof provided that such levy of tolls shall not be applicable to non-commercial motor vehicles owned by the residents of Kodaikanal Municipal area :-
