ORDER:

In the Government Order read above, the Government Issued orders notifying the formation of the Tamil Nadu Folk Artistes Welfare Board (தமிழ்நாடு நாட்டுப்புறக் கலைஞர்கள் நல வாரியம்) to provide Social Security and Welfare measures for the Artistes engaged in Folk Arts.

2) To implement the Tamil Nadu Folk Artistes Social Security and Welfare Schemes, the Government sanction an Initial amount of Rs.1,00,00,000/- (Rupees One Crore Only) as budgetary support to the Tamil Nadu Folk Artistes Welfare Board.

3) The amount sanctioned in paragraph 2 above shall be debited to a new sub-head of account to be opened under Demand No.29, Tourism - Art and Culture as detailed below :-

“2205.00 Art and Culture – 102 Promotion of Arts and Culture – I – Non-Plan – AL Grants to Tamil Nadu Folk Artistes Welfare Board – 09 – Grants –in-aid- 01 Grants for current Expenditure (DPC 2205-00-102-AL 0912)

4) The Commissioner (in-charge) of Directorate of Art and Culture is the estimating, reconciling and controlling authority for the above new head of account.

5) The Pay and Account Officers / Treasury Officers concerned are requested to open the above new head of account in accounts under their jurisdiction.

6) The expenditure sanctioned in paragraph 2 above will be treated as a "NEW SERVICE". The approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure shall be initially met by sanction of an advance from the "CONTINGENCY FUND", for which orders will be issued by Finance (B.G.I) Department separately. The Commissioner (in-charge) of Directorate of Art and Culture is requested to send necessary proposals directly to Government in Finance (B.G.I) Department in the prescribed form, enclosing a copy of this order for sanction of an advance from the Contingency Fund. The Commissioner (in-charge) of Directorate of Art and Culture is requested to send necessary proposals to Government in Finance Department to include this expenditure in the supplementary Estimates, 2007-2008, without fail.

7) This order issues with the concurrence of Finance Department vide its U.O No. 388/SS(PK)/Edn.II/07, dated: 4.1.2007 and with Additional Sanction Ledger No. 1623 (One thousand six hundred and twentythree)
