### **ORDER:**

In G.O first read above orders have been issued, among other things, accepting in principle to implement the National Health Insurance Scheme for BPL Families in Kancheepuram and Tirunelveli Districts of Tamil Nadu on pilot basis, as per the guidelines issued by the Government of India. Orders have also been issued constituting a State Level Inter-departmental Co-ordination and Monitoring Committee under the Chairmanship of the Secretary to Government, Labour and Employment Department.

2. The Commissioner of Labour, Chennai in his letter second read above, has sent proposal based on the decisions taken in the preliminary meeting held on 22.2.2008 for implementation of the scheme to constitute District Level committee in Kancheepuram and Tirunelveli Districts. In the letter third read above, proposals have been received to appoint the District Information Officers (NIC) in Kancheepuram and Tirunelveli Districts as “District Key Management Agency” for the respective districts so as to have software security during the operation of the issue and use of smart key to each beneficiary in the villages / wards.

The Government, after careful examination, accept the above proposal and constitute District Committee in Kancheepuram and Tirunelveli Districts under the chairmanship of the District Collectors concerned, with the following officers in the respective districts, for implementation of the National Health Insurance Scheme for BPL families at district level:
