



ABSTRACT

Telephones - Fixation of ceiling on free calls to the direct line telephones connected to the Fax /Computer machines functioning at the offices of the Government Officers – Orders –Issued.

ORDER:

In the G.O read above orders were issued revising the ceiling on free calls to the office and residential telephones of the Government officers. The Ceiling on free calls to the office telephones was fixed as follows:

(i)	Direct line Telephones attached to Secretaries /Additional Secretaries to Government /Heads of Departments	5000 free calls bi-monthly excluding rental charges
(II)	All other office telephones	3500 free calls bi-monthly excluding rental charges

In the above G.O ceiling on expenditure on telephones connected to the Fax machines and Computers of Secretaries to Government .Second level officers and Departments were not prescribed. With a view to control the expenditure on telephones, which are connected to the Fax machines and computers, the question of prescribing ceiling on expenditure to these telephones was examined.

2. The Government after careful consideration directs that the ceiling on expenditure on telephones connected to the Fax machines and Computers shall be prescribed as mentioned below:

1	Direct line Telephones of Secretaries to Government / Special Secretaries to Government Additional Secretaries to Government /Heads of Departments Connected to fax machines / Computers.	Additional 2000 free calls bi-monthly (apart from the 5000 calls allowed to these Telephones) (Total 5000 + 2000 =7000 free calls)
2	Direct line Telephones of Second level officers in Secretariat and Directorates Connected to fax machines or Computers.	Additional 1500 free calls bi-monthly (apart from the 3500 calls allowed to these Telephones) (Total 3500 + 1500=5000 free calls)
3	Separate direct line telephone connected exclusively to fax or Computer.	3000 free calls bi-monthly

The above orders shall take effect from the date of issue of orders.
