ORDER:

The Advocate General of Tamil Nadu, High Court of Madras in his letter third read above has sent a proposal to Government for revision of Retainer fees and fees for appearance and drafting to the Law Officers on Civil side in the High Court of Madras and its Bench at Madurai.

2. The Government after careful consideration of the proposal of the Advocate General for revision of Retainer fees and fees for appearance and drafting to the Law Officers in the High Court of Madras and its Bench at Madurai have decided to revise the rates of fees to the Law Officers, (Civil side) High Court and issue orders as follows:-

3. The Government have also decided to sanction conveyance allowance at the rate of Rs.1,500/-p.m. to all the Law Officers on civil side except those who have been provided with car. (ie, Advocate General, Additional Advocate Generals, Public Prosecutor and Government Pleader).

4. The expenditure on Retainer fee sanctioned in para 2(i) above shall be debited to the head of account "2014.00 . Administration of Justice -114. Legal Advisors and Counsels -I. Non-Plan-AK. Directorate of Litigation - 33. Payment for Professional and Special Services-01. Salaries 02. Remuneration" (DPC No. 2014.00.114.AK.3328). The expenditure on conveyance allowance sanctioned in para 3 above shall be debited to the head of account "2014.00. Administration of Justice - 114. Legal Advisors and Counsels -I. Non-Plan - AK. Directorate of Litigation-01. Salaries-04. Other Allowances" (DPC 2014.00.114.AK.0143).

5. This order shall take effect from the date of issue of this order.

6. Necessary amendments to Law Officers, High Court Standing Order-Part -I and Part-II will be issued separately.

7. The total expenditure of Rs. 24,00,000/- per annum sanctioned in para 2(i) and 3 above shall constitute an item of "New Service" for which approval of the Legislature will be obtained in due course. Pending approval of the Legislature, initial expenditure will be met by an Advance from the Contingency Fund. The Director of Litigation, Chennai shall send necessary application in duplicate to Government in Finance (BG-I) Department for sanction of Advance from the Contingency Fund.
