### **ORDER:**

The Ministry of Small Scale Industries, Government of India, in their Notifications first and second read above, have specified the authorities with whom the industrial entrepreneurs' memorandum shall be filed in respect of medium enterprise engaged in the manufacture or production of goods and medium enterprise engaged in providing or rendering of services, as specified in clauses (c) and (b), respectively, of sub-section (1) of section 8 of the Micro, Small and Medium Enterprises Development Act, 2006.(Central Act 27 of 2006)

2. The Industries Commissioner and Director of Industries and Commerce in his letter 4th read above, has requested to issue executive instructions notifying the authorities with whom the industrial entrepreneurs' memorandum shall be filed under clauses (c) and (b) respectively, of sub-section (1) of section 8 of the said Act.

3. The Government have examined the proposal of the Industries Commissioner and Director of Industries and Commerce and direct that the General Manager, District Industries Centres, having jurisdiction in respect of the districts concerned, except Chennai district and the Regional Joint Director

of Industries and Commerce having jurisdiction in respect of Chennai district shall be the authorities with whom the memorandum shall be filed by a person who intends to establish or has already established, a Medium enterprise engaged in the manufacture or production of goods as specified in clause (c) of sub section (1) of section 8 of the Micro, Small and Medium Enterprises Development Act, 2006 (Central Act 27 of 2006) or a medium enterprise engaged in providing or rendering of services as specified in clause (b) of sub-section (1) of section 8 of the said Act.
