**ORDER:-**

In the Government Order first read above, State Level Steering cum Monitoring Committee has been constituted under the Chairmanship of Development Commissioner and Principal Secretary, Finance Department as per the Para 3.5.7 of the Guidelines of National Programme of Nutritional Support to Primary Education, 2006.

2. In the Government Order second read above and letters second and third read above, the State Level Steering cum Monitoring Committee has been re-constituted under the Chairmanship of Chief Secretary consisting the following Members as follows:-

4. Atleast one representative of teachers.

4. After careful consideration of the proposal, the Government accept the above proposal of the Director of Social Welfare mentioned at para – 3 above and issue the orders accordingly.

5. The term of Members nominated under other Members category will be two years or till the nomination of their successors, whichever is later.

6. The State Level Steering cum Monitoring Committee will perform the following functions :-

- i. Guiding various implementation agencies ;
- ii. Monitoring Programme implementation, assessing its impact and taking corrective steps ;
- iii. Taking action on reports of independent monitoring / evaluation agencies ;
- iv. Effecting coordination and convergence among concerned department, agencies (eg. Food Corporation of India) and schemes ; and
- v. Mobilising community support and promoting public private partnership for the programme

7. The State Level Steering cum Monitoring Committee will meet at least once in every six months. The Non-official Members of the Committee shall be entitled for TA / DA and other allowances on par with first class Committee.
