ORDER:

In the letter read above, the Commissioner of Social Defence has informed that at present the kitchen utensils provided to the Government Children Home for Boys, Chengalpattu & Thanjavur and Government Vigilance Home, Chennai were purchased 3 years back. Since the utensils purchased was not adequate to the above institutions. Hence, it very essential to provide additional utensils to the above institutions. So to effect the supply of utensils, proposal is included in the Part II Schemes 2007-2008.
