ORDER :

The Standing Finance Committee has approved the proposal for Modernisation of Kitchen of 2000 Child Centres (Anganwadi Centres) under Integrated Child Development Services Scheme at a total cost of Rs.1.54 crore (Rs.24.00 lakh as Recurring expenditure and Rs.1.30 crore as Non-recurring expenditure) under State funds by supplying LPG connection, Stove and Pressure Cooker along with Electrification under Part-II scheme for the year 2008-2009.

2) The Director, Integrated Child Development Services Scheme has proposed for supply of LPG connection, Stove and Pressure Cooker along with Electrification to 2000 Child Centres (Anganwadi centres)for the year 2008-2009 at the rate of 744 centres in Chennai District, 784 centres in Tirunelveli District, 36 centres in Thiruvarur District, 202 Centres in Karur District and 234 centres in Perambalur District at the rate of Rs.7700/- per Child Centre per annum (Rs.6500/- as Non-recurring and Rs.1200/- as Recurring) at a total cost of Rs.1.54 crore.

3) The Government after careful examination have decided to accept the proposal of the Director, Integrated Child Development Services Scheme as approved by the Standing Finance Committee and order as follow:-

- (i) The Government accord sanction to incur an amount of Rs.1.30 crore (Rupees One Crore and thirty lakh only) towards Non-recurring expenditure to provide LPG connection, Stove and Pressure Cooker along with Electrification to 2000 Child Centres (AWCs) under Integrated Child Development Services Scheme in Tamil Nadu at the rate of 744 centres in Chennai District, 784 centres in Tirunelveli District, 36 centres in Thiruvarur District, 202 Centres in Karur District and 234 centres in Perambalur District at the rate of Rs.6500/- (Rupees Six thousand and five hundred only) per Child Centre per annum as non-recurring expenditure and Rs.24.00 lakh (Rupees Twenty four lakh only) as recurring expenditure for supply of LPG cylinders at the rate of Rs.1200/- (Rupees one thousand and two hundred only) (Rs.300 x 4 cylinders for 4 quarters in a year) per annum as detailed in the Annexure I and II to this order.
- (ii) The Government authorise the District Programme Officers (ICDS) of Chennai, Tirunelveli, Thiruvarur, Karur and Perambalur districts to draw the above sanctioned non-recurring expenditure amount intended for their district as detailed in the Annexure-II to this order as advance under Article 99 of Tamil Nadu Financial Code Volume-I and to implement this order following the purchase procedure as per the rules in force and to settle this advance with the concerned Pay and Accounts Officer/Treasury Officer with the bills and vouchers expeditiously.
- (iii) The Government direct the Director, Integrated Child Development Services Scheme to permit the District Programme Officers (ICDS) of concerned districts to incur the recurring expenditure of Rs.24.00 lakh intended for their Districts as detailed in the Annexure-II to this order.
- (iv) The expenditure sanctioned above shall be debited to the following head of account:-
