ORDER:

In the reference first read above, the Government of India have sanctioned adhoc grant of central assistance towards transportation cost of food grains to the tune of Rs.249.85 lakh for 2008-09 for primary stage and upper primary stage of education under National Programme of Mid Day Meals in Schools. Accordingly, orders have been issued sanctioning a sum of Rs.249.85 lakhs as adhoc grant of central assistance towards transportation cost of food grains under NPMDMS, in the reference second read above.

2. In the reference third read above, the Government of India have sanctioned a sum of Rs.231.46 lakh towards balance amount of first instalment of central assistance for transportation of food grains under NPMDMS for 2008-09, after adjusting the unspent balance.

3. In the reference fourth read above, the Government of India have sanctioned a sum of Rs.499.73 lakh towards second and final instalment of central assistance for transportation of food grains under NPMDMS for 2008-09. The details of funds released so far, towards transportation of food grains under NPMDMS for 2008-09 is as follows :-

4. In pursuance of sanction of the central assistance towards transportation cost of food grains, sanction is accorded to incur the expenditure of Rs.499.73 lakhs (Rupees four hundred and ninety nine lakhs and seventy three thousand only) by the Commissioner of Social Welfare, being the second and final instalment of central assistance towards transportation of food grains for the year 2008-09 under NPMDMS.

5. The expenditure sanctioned above shall be debitible under the following head of account :-

“ 2236 – Nutrition – 02 – Distribution of Nutritious food and beverages – 102 – Mid Day Meals – III Centrally Sponsored – SA – National Programme of Nutritional Support to Primary Education (Mid Day Meal Scheme) – 09 – Grants-in-aid – 03 – Grants for specific schemes – (DPC No.2236 02 102 SA 0935)

6. Necessary funds have been provided in RE 2008-09 to meet the expenditure sanctioned in para-4 above.

7. The Commissioner of Social Welfare is permitted to implement the scheme and to redistribute the amount sanctioned in para-4 above to the Tamilnadu Civil Supplies Corporation, Chennai 10, who is the State Nodal Agency for transportation of food grains and to settle the bills relating to transportation of food grains as and when the bills presented by the Tamilnadu Civil Supplies Corporation after reconciled by the Food Corporation of India.

8. The Commissioner of Social Welfare is directed to maintain a separate and proper account of the money received and make appropriate budget provision in the State Budget and shall utilize the grant in aid for transportation of food grains under Mid Day Meal Scheme in accordance with the provisions of the Rules and not to divert the money for any other purpose, subject to the provisions of NPNSPE, 2006.

9. The Commissioner of Social Welfare shall furnish the utilization certificate to the Government as well as quarterly progress reports for every quarter ending.
