**The following notification will be published in the Tamil Nadu Government Gazette:**

### **NOTIFICATION:**

In exercise of the powers conferred by sub-section (1) of section 16 of the Tamil Nadu Welfare Board for the Disabled Persons Act, 2007 (Tamil Nadu Act 18 of 2007), the Governor of Tamil Nadu hereby makes the following Rules:-

1. **Short Title and Commencement** : (i) These rules may be called the Tamil Nadu Welfare Board for the Disabled Persons Rules, 2008  
(ii) It shall come into force at once .
2. **Definitions:-** In these rules, unless the context otherwise requires:-
  - (a) "Act" means the Tamil Nadu Welfare Board for the Disabled Persons Act 2007 (Tamil Nadu Act 18 of 2007);
  - (b) "Board" means the Board established under section 3 of the Act

3. Term of office of Members:- A non-official member of the Board shall hold office for a period of three years commencing from the date on which his appointment is first notified in the Tamil Nadu Government Gazette.
4. Sources of Funds to be received:- All monies received from various Ministries of Central Government or State Government, World Bank, United Nations Children's Fund (UNICEF) and other International Funding agencies, Philanthropists and individuals shall be credited to the Fund constituted under sub section (1) of section (6) of the Act.
5. Maintenance and Audit of Accounts:- The Accounts of the Board shall be maintained by the Accounts Officer of the Board and shall be audited by the Director of Local Fund Audit, Chennai once a year . The annual statements of accounts and balance sheet shall be prepared in the Form annexed to this rules . The Member – Secretary of the Board shall be responsible for the disposal of the audit note.
6. Board Secretariat:- The Chairperson shall be assisted by the Member – Secretary in the discharge of the functions of the Board. The Member-Secretary in consultation with the Chairperson and the Vice-Chairman shall constitute a panel of experts and other staff for the Board with the approval of the Government. The salary and allowances for the experts and staff will be met out of the funds allotted to the Board.
