### ORDER:

In the letter first read above, the Government of India have conveyed the sanction for the payment of non recurring grant in aid of Rs.114.00 lakh (Rupees one hundred and fourteen lakh only) for construction of 190 kitchen-cum-store in this State upto a maximum of Rs.60,000/- (Rupees sixty thousand only) per unit in Government and local body schools in 44 Educationally Backward Blocks for 2007 - 08 under the NPMDM in schools subject to the conditions / rules in force.

2. In pursuance of the sanction of central assistance under NPMDM in schools, the Director of Social Welfare was requested to send necessary proposal for utilizing the central assistance towards construction of 190 kitchen cum store at the rate of Rs.60,000/- per unit / school in Government and local body schools in 44 Educationally Backward Blocks under National Programme of Mid Day Meals in Schools (MDM Scheme) for 2007-08. Accordingly, the Director of Social Welfare has sent necessary proposal and requested the Government for redistributing the same among 44 Educationally Backward Blocks in 11 districts at the rate of Rs.60,000/- each for construction of 190 kitchen cum store.

3. After careful examination of the proposal of the Director of Social Welfare, sanction is accorded for incurring an expenditure of Rs.114.00 lakh (Rupees one hundred and fourteen lakh only) towards construction of 190 kitchen cum store at the rate of Rs.60,000/- per unit / school in Government and local body schools in the Educationally Backward Blocks in the three districts viz., Cuddalore, Krishnagiri and Villupuram under National Programme of Mid Day Meals in Schools (MDM Scheme) for 2007-08.

4. The expenditure sanctioned in para 3 above shall be debitible under the following head of account :-

“ 4236 – Capital outlay on Nutrition 02 – Distribution of Nutritious Food and Beverages – 800 Other Expenditure – Schemes under Eleventh Five Year Plan – III – Centrally Sponsored Scheme – SC – National Programme of Nutritional Support to Primary Education (Mid Day Meal Scheme) – Construction of kitchen – cum – store – 16 Major works” (DPC No.4236 02 800 SC 1605)

5. The expenditure sanctioned in para – 3 above, is provided in FSE 2007-08.

6. The Director of Social Welfare is permitted to implement the scheme of construction of kitchen-cum-store in Cuddalore, Krishnagiri and Villupuram Districts, following the guidelines of NPNSPE 2006 and the conditions stipulated therein. The Director of Social Welfare is permitted to redistribute the amount according to the number of centres sanctioned in para-3 above among the three districts as given below:-

7. The Director of Social Welfare and District Collectors are instructed to adopt design of the kitchen-cum-store as suggested in Annexure – IX read with para 4.2 of NPNSPE Guidelines, 2006 as far as possible.

8. The Director of Social Welfare / District Collectors shall maintain a register of immovable properties and other such records as prescribed in the Rules, and they are instructed to utilize the amount sanctioned in para-3 above in full and furnish the utilization certificate to Government early for onward transmission to Government of India.

9. All the District Collectors are instructed to provide infrastructural elements to the nutritious meal centres by convergence with other development programmes as envisaged in para 2.5 of the NPNSPE Guidelines, 2006.

10. The Government permit the Director of Social Welfare to draw the amount sanctioned as advance under Article 99 of Tamilnadu Financial Code Vol.I. by presenting bill at Pay and Accounts Office (East) and distribute the amount to the District Collectors concerned. The Pay & Accounts Officer (East) is instructed to admit the bills, if otherwise found in order so as to enable to draw the amount on or before 31-03-2008, as a special case.
