ORDER:

The Member Secretary, Sports Development Authority of Tamil Nadu in his letter first read above has stated that the District Sports Complex at Tiruvannamalai has been established with 400 m athletic track, football, hockey, basketball, volleyball courts and a weightlifting hall and it is felt very essential to construct a swimming pool in the District Sports Complex, Tiruvannamalai. The Member Secretary, Sports Development Authority of TamilNadu, has stated that the District Collector, Tiruvannamalai has earmarked the land for the construction of the swimming pool measuring 25m x 13m in the District Sports Complex, Tiruvannamalai at an estimated cost of Rs.66 lakhs. He has stated that the District Revenue Administration will provide Rs.33 lakhs for the above project and the balance of Rs.33 lakhs has to be provided by the Government.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to provide necessary funds to the tune of Rs.33 lakhs (non-recurring) under the Part-II Schemes 2007-2008, for the construction of swimming pool at Tiruvannamalai.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction for an expenditure of Rs.33,00,000/- (Rupees Thirty Three Lakhs only) as non-recurring expenditure for the construction of swimming pool at Tiruvannamalai, under the Part-II Schemes for the year 2007-2008.

4. The expenditure sanctioned in paragraph 3 above shall be debited to the following head of account::

“2204 - 00 Sports and Youth Services – 104 Sports and Games – Schemes in the Eleventh Five Year Plan – II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of

Sports Complex – 09 Grants-in-Aid – 03 Grants for specific schemes” (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill for the amount sanctioned in paragraph 3 above and present it at the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The above sanctioned amount shall not be paid in cash but shall be credited into the following head of account:

"K.Deposits and Advances (B) Deposits not bearing interest – 8443 00 Civil Deposits – 800 Other deposits – CH – Deposits of Tamil Nadu Sports Development Authority (DPC 8443 00 800 CH 000D)" by means of cheque / demand draft drawn in favour of **PD Account No.6184513932**".

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate, completion certificate etc., to Government in due course.
