Sports – Construction of Sports Hostels at Tirunelveli and Erode with all facilities – A sum of Rs.56 lakhs (Rupees Fifty Six Lakhs only) (Non-Recurring) out of the ultimate cost of Rs.140 lakhs – Expenditure sanctioned under Part-II Schemes for the year 2007-2008 – Orders issued.

ORDER:

The Member Secretary, Sports Development Authority of Tamil Nadu in his letter first read above has stated that Sports Development Authority of Tamil Nadu provides sports school and hostel facilities to outstanding sportspersons of Tamil Nadu, to avail Hostel facility, sports infrastructure facility and study in various schools. An exclusive sports hostel is also being run for girls in Erode. He has stated that every year, outstanding sportspersons from 7th, 8th, 9th and 11th standards are being spotted and are being allotted to the sports hostel and sports schools in various districts of Tamil Nadu. Now, there are about 120 boys in the Tirunelveli Sports Hostel and 120 girls in the Erode Sports Hostel getting sports facilities and studying in nearby schools. In order to provide proper accommodation facilities with modern amenities for 120 boys in Tirunelveli and 120 girls in Erode and also to construct a kitchen and dining facility, a sum of Rs.70.00 lakhs is required for each hostel.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to provide necessary funds to the tune of Rs.140 lakhs (non-recurring) under the Part-II Schemes 2007-2008, for the construction of sports hostels at Tirunelveli and Erode with all facilities.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction for an ultimate non-recurring cost of Rs.140 lakhs for the construction of sports hostels at Tirunelveli and Erode with all facilities, under the Part-II Schemes for the year 2007-2008 and accord sanction for an expenditure of Rs.56,00,000/- (Rupees Fifty Six Lakhs only) towards the cost for the year 2007-2008 for the construction of Hostels at Tirunelveli and Erode.

4. The expenditure sanctioned in paragraph 3 above shall be debited to the following head of account:

“2204 - 00 Sports and Youth Services – 104 Sports and Games – Schemes in the Eleventh Five Year Plan – II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex – 09 Grants-in-Aid – 03 Grants for specific schemes” (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill for the amount sanctioned in paragraph 3 above and present it at the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The above sanctioned amount shall not be paid in cash but shall be credited into the following head of account:

"K.Deposits and Advances (B) Deposits not bearing interest – 8443 00 Civil Deposits – 800 Other deposits – CH – Deposits of Tamil Nadu Sports Development Authority (DPC 8443 00 800 CH 000D)" by means of cheque / demand draft drawn in favour of **PD Account No.6184513932**".

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government in due course.
