### ORDER:

The Member Secretary, Sports Development Authority of Tamil Nadu in his letter first read above has stated that the indoor stadium at Periamet was constructed during 1994-1995 with a seating capacity of 8000 and wooden flooring to enable the conduct of sports activities such as basketball, volleyball, badminton, chess & table tennis. He has stated that due to the exposure to sun and rain, the existing roof is leaking and owing to this, the wooden flooring in various places is getting damaged and sports activities are also affected. Therefore, the Member Secretary has proposed to re-roof the existing roofing of the Multi-purpose Indoor stadium at Chennai at a cost of Rs.200.00 lakhs.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to provide necessary funds to the tune of Rs.200 lakhs (non-recurring) under the Part-II Schemes 2007-2008, for re-roofing the multipurpose indoor stadium at Periamet, Chennai.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction for an expenditure of Rs.200 lakhs (Rupees Two Hundred Lakhs only) as non-recurring expenditure for re-roofing the multipurpose indoor stadium at Periamet, Chennai, under the Part-II Schemes for the year 2007-2008.

4. The expenditure sanctioned in paragraph 3 above shall be debited to the following head of account:

“2204- 00 Sports and Youth Services – 104 Sports and Games – Schemes in the Eleventh Five Year Plan – II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex – 09 Grants-in-Aid – 03 Grants for specific schemes” (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill for the amount sanctioned in paragraph 3 above and present it at the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The above sanctioned amount shall not be paid in cash but shall be credited into the following head of account:

"K.Deposits and Advances (B) Deposits not bearing interest – 8443 00 Civil Deposits – 800 Other deposits – CH – Deposits of Tamil Nadu Sports Development Authority (DPC 8443 00 800 CH 000D)" by means of cheque / demand draft drawn in favour of **PD Account No.6184513932**".

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate, completion certificate etc., to Government in due course.
