

NEW HEALTH INSURANCE SCHEME

Salient Features:

1. Announcement of the Scheme:

The Honourable Chief Minister of Tamil Nadu has announced the New Health Insurance Scheme for the benefit of the employees.

2. Commencement of the Scheme:

The Scheme commences from 11.06.2008

3. Coverage of the Scheme:

It covers the employees of :

- Government Departments
- Local Bodies
- State Public Sector Undertakings
- Statutory Boards
- State Government Universities

The scope of coverage includes:

- Cost of Medicine
- Laproscopic or open surgeries
- Doctors and attendant fees
- Room, diagnostic and dietary charges

4. Eligibility

The eligible members of the family of the employee are as follows:

- Legal Spouse
- Children till employed or married or attaining the age of 25 years
- Parents of unmarried employee until the employee gets married

The employees not eligible are:

- Appointed under rule 10(a)(1) of Tamil Nadu State and Sub-ordinate Service
- Working on consolidated pay and daily wage basis
- Employees of organisation registered under the Societies Registration Act

5. Eligible Amount of Medical expenses :

The eligible amount of benefit is Rs.2 Lakhs over a block period 4 years and can be availed individually or collectively by the members of the family on a cashless basis .

6. Subscription :

The monthly subscription is Rs.25 per month and recovered from the salary of June 2008 and the annual subscription amounts Rs.300(Rs.25*12)

7. Premium paid to the Insurance company:

The annual premium payable to the insurance company is Rs.495 plus 12.5% service tax. The Government will pay the additional expenditure amount of Rs.195 per year and the entire 12.5% service tax.

8. Diseases Treatments, Surgeries and Hospitals.

There are 52 types of diseases/Treatments and Surgeries and more than 200 Nos. of Hospitals covered .
